²⁾RUCO-PLAST EPG 18764 contains formaldehyde. As the content of formaldehyde on the finished textiles very much depends on the application conditions especially on the application method used and on the add-on quantities, compliance of the finished textiles with the limit values for formaldehyde given according to the above mentioned OEKO-TEX® Standard 100 has to be calculated or checked individually under the prevailing application conditions.



³⁾RUCO-PLAST KLH contains small amounts of formaldehyde (CAS 50-00-0). According to our knowledge, the limit value for formaldehyde on finished goods of 16 ppm will be met, providing the product is used in line with the Technical Leaflet.

According to **OEKO-TEX® Standard 100**, only textile products are certified. Certification is only carried out by independent, accredited **OEKO-TEX®** test institutes. Therefore, we do not have **OEKO-TEX® Standard 100** certificates for our products. We can only confirm if products will be suitable or not for textiles which will fulfil the requirements of the above mentioned **Standard 100 by OEKO-TEX®**.
